4. Distinctive Features of the Programme and the Student Experience

Osteopathy is a patient-centered approach to a wide range of medical conditions through a system of diagnosis and management. Osteopathy also includes patient self-help and education to improve function, reduce recurrence, and the promotion of well-being.

Changes in healthcare and education have revealed exciting opportunities for the osteopathic profession nationally and globally. BCOM & ESO (BCNO Group) are both internationally recognised osteopathic schools that merged in September 2021 to expand educational pathways; this provides options for flexible study and innovative and topical learning experiences. Under the banner of the BCNO Group, the group collaborates closely with fellow osteopathic educational institutions (OEI) internationally and nationally.

The MSc in Osteopathy for Diplomates has been designed for osteopaths who have graduated with an osteopathic diploma and a BSc (Hons) or equivalent. The MSc for Diplomates offers flexibility in teaching and learning delivery through block face-to-face teaching, streaming, and self-directed learning. Practical sessions will be delivered face-to-face with appropriate faculty supervision. Online learning resources and the content will also support practical subjects with additional material. The BCNO Group utilises technology to enhance the student experience, teaching, and learning. Students will also have access to a more extensive student network for learning purposes and networking. The MSc allows students who already have a healthcare undergraduate degree, following on from their osteopathic Diploma to study for a MSc.

Both ESO and BCOM have experience in teaching students off-site through block teaching and using technology. BCOM has in the past successfully run a University of Plymouth BSc (Hons) in osteopathy course across European sites. ESO has experience in providing a Diploma in Osteopathy across mainland Europe.

The curriculum continues from the ESO Diploma in Osteopathy, designed to consider the WHO Benchmark in Osteopathic Training and changes in regulation within Europe. The programme includes modules which evaluate advanced techniques in osteopathy in a number of healthcare conditions. Further modules equip the students with the skills and techniques to critically evaluate and manage patients with long term health needs. The course is designed to develop the osteopath's clinical decision making and understand the changing needs in healthcare and the role osteopathy plays in the care and management of patients.

The programme utilises a range of assessments that are designed to be stimulating and challenging, stretching the students' knowledge and practical skills.

Assessments include coursework, dissertations, reflective accounts, portfolios, ISCE (Integrated Structured Clinical Examination) and clinical assessments as individual students or group work.

7. Programme Aims

The overall aim is to provide a stimulating appropriate teaching and learning environment to create a self-reflective effective osteopath who can work in contemporary healthcare. Graduates will understand professional and interprofessional practice in modern healthcare practice. The programme aims to:

 Provide the student with knowledge and skills reflective of advancing healthcare standards in osteopathy;

- Develop the student's competence in applying clinical skills to osteopathic practice;
- Develop the reflective, critical, and analytical skills of the student, allowing them to deal with complex issues, making sound judgments in the absence of complete data, and promoting excellence in osteopathic professional practice;
- Develop reflective practice and communication skills to develop an effective partnership with patients and other healthcare professions
- Develop general problem-solving, key-transferable, and research skills to allow the student to understand evidence-based practice and become autonomous practitioners.
- Enhance reflective skills to produce effective, safe osteopaths

8. Programme Intended Learning Outcomes (PILOs)

Students on the **Master of Science in Osteopathy for Diplomates** programme will be required to achieve all the Programme's Intended Learning Outcomes (PILOs).

8.1. Knowledge and understanding

On successful completion, graduates should have developed:

- An in-depth critical understanding of the key skills, knowledge, research, concepts and principles required as an autonomous osteopathic practitioner in modern healthcare.

- 1) The ability to apply relevant problem-solving skills and, synthesise appropriate information and data to underpin clinical reasoning in patient-centred care.
- 2) The ability to critically evaluate specialist information to allow the formulation of complex patient care

8.3. Key and transferable skills

On successful completion, graduates should have developed the ability to:

- 1) Employ a range of transferable skills (such as organisational skills, and criticality) that are relevant and effective across several settings.
- 2) Efficiently organise and communicate complex information to a variety of audiences using relevant technology
- 3) To be able to work as an autonomous osteopathic practitioner and work with a critical understanding of relevant professional standards and legislation.

8.4. Employment-related skills

On successful completion, graduates should have developed:

- Relevant professional knowledge and skills to deliver and exercise professional judgement as an autonomous osteopathic practitioner, inclusive of patient-centred care
- 2) The ability to develop a critical reflective osteopathic clinical practice
- 3) The ability to critically utilise complex information to develop their clinical practice.

8.5. Practical skills

On successful completion, graduates should have developed:

- 1) The understanding and reflective ability in osteopathic and clinical skills that allow the effective and safe management of complex patients
- 2) The ability to apply relevant research skills in a wide range of contexts applicable to osteopathic practice.
